1. Call to Order/determination of Quorum

2. A) Approval of the Minutes of the Board of Directors Meeting held May 23, 2017. On a Motion made, seconded and unanimously passed the above Minutes were approved as submitted.

3. Open Forum

A) Clint Blomberg - Tree Removal Appeal: Mr. Blomberg gave a brief synopsis of his request to have his matter resolved. Joe Jackowski stated since requests for tree removal were done jointly, he is not sure if this issue can be resolved separately. Joe stated he will speak to the HOA attorney to see if possible to split tree removal. Joe and Mr. Blomberg will plant to met on Thursday, July 29th at 9:30am to discuss outcome.

B/9B) Bob Stockton - ACC discussion re: Residential Guidelines changes: In regards to section 5.2, Bob Stockton stated that the ACC feels that tree removal/limbing still needs to be regulated. It was suggested that the ACC review the Guidelines and come up with alternate wording to present to the Board at their next meeting.

4. Site Managers Report

A1) Split Rail Fence repair: Site Manager reported that once a split rail fence is down/rotted, the HOA is not required to replace/repair it. The Board stated that once the fence is down, the county plaque should be mounted on a permanent, metal post. The Board is declaring a policy on split rail fencing. The following Motion was made: The HOA does not plan to replace split rail fencing. The fence is solely for purposes of delineating wetlands. County signs will be placed on metal posts as required by county regulation. Discussion was had and Board member Sue Barrett stated that the fence has a purpose to hold back underbrush. It was also stated that if a resident wants to replace the fence at their cost, that would be approved. The Motion was seconded, and passed with 3 in favor, 1 opposed.

It would be allowed, but keep this area tidy and not allow sand to go into the storm drain. Joe Jackowski stated he will talk to Brent Cohen about this matter at their next meeting.
- **D)** Review asphalt patching and crack fill quotes: The Board reviewed the 3 quotes that had been received. The Board requests that the Site Manager send these quotes to Dick Day for review and then send his response to Board for final decision of asphalt vendor.
